A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA ENTERING A LEASE PURCHASE AGREEMENT BETWEEN PNC EQUIPMENT FINANCE, LLC AND CITY OF RIALTO, CALIFORNIA (LESSEE)

WHEREAS, the budget for fiscal year 2020-2021 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

WHEREAS, the Governing Body hereby finds and determines that the execution of one or more Master Lease-Purchase Agreements ("Leases") in the principal amount not exceeding \$1,662,374.59 for the purpose of acquiring the property ("Equipment") to be described in the Leases is appropriate and necessary to the functions and operations of the City of Rialto ("City").

WHEREAS, PNC Equipment Finance, LLC ("Lessor") shall act as Lessor under said Leases.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

20 Either one of the Mayor or City Manager, or a designee of the Mayor or City Section 1: 21 Manager (each an "Authorized Representative") acting on behalf of the City, is hereby authorized to 22 negotiate, enter into, execute, and deliver one or more Leases in substantially the form set forth in the 23 document presently before the Governing Body, which document is available for public inspection at the 24 office of the City. Each Authorized Representative acting on behalf of the City is hereby authorized to 25 negotiate, enter into, execute, and deliver such other documents relating to the Lease as the Authorized 26 Representative deems necessary and appropriate. All other related contracts and agreements necessary 27 and incidental to the Leases are hereby authorized.

<u>Section 2:</u> By a written instrument signed by any Authorized Representative, said
Authorized Representative may designate specifically identified officers or employees of the City to
execute and deliver agreements and documents relating to the Leases on behalf of the City.

Section 3: The aggregate original principal amount of the Leases shall not exceed the amount of \$1,662,374.59 and shall bear interest as set forth in the Leases and the Leases shall contain such options to purchase by the City as set forth therein.

Section 4: The City's obligations under the Leases shall be subject to annual appropriation or renewal by the City Council as set forth in each Lease and the City's obligations under the Leases shall not constitute general obligations of the City or indebtedness under the Constitution or laws of the State of California.

Section 5:As to each Lease, the City reasonably anticipates to issue not more than\$10,000,000 of tax-exempt obligations (other than "private activity bonds" which are not "qualified501(c)(3) bonds") during the current calendar year in which each such Lease is issued and herebydesignates each Lease as a qualified tax-exempt obligation for purposes of Section 265(b) of the InternalRevenue Code of 1986, as amended.

Section 6: This resolution shall take effect immediately upon its adoption and approval.
