

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ORDERING THE PREPARATION OF AN ENGINEER'S REPORT FOR LANDSCAPE MAINTENANCE DISTRICT NO. 1 TO ESTABLISH ANNUAL ASSESSMENTS FOR FISCAL YEAR 2021/2022.

WHEREAS, the City Council of the City of Rialto, California, (hereinafter the "City Council"), has by previous Resolution established the Landscape Maintenance District No. 1, pursuant to the provisions of the Landscaping and Lighting Act of 1972, Part 2 of Division 15 of the Streets and Highways Code of the State of California, beginning with §22500 (hereafter referred to as the "Act"), that provides for the levy and collection of assessments by the City of Rialto to pay for the maintenance and services of improvements and all appurtenant facilities and operations related thereto; and

WHEREAS, §22566 and §22622 of the Act requires the preparation of an Engineer's Report to determine and adjust the annual assessment rates for Landscape Maintenance District No. 1.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

<u>Section 1:</u> Webb Municipal Finance, LLC is hereby ordered to prepare and appropriately file the Engineer's Report required to determine and adjust the Landscape Maintenance District No. 1 assessments for Fiscal Year 2021/2022 in accordance with §22566 and §22622 of the Act. The Engineer's Report shall be filed with the City Clerk for submission to the City Council.

<u>Section 2:</u> The improvements to be operated and maintained by Landscape Maintenance District No. 1 generally include the operation, administration, maintenance, and servicing of streetscape landscaping including parkways and medians as well as public landscaped areas, including turf, ground cover, plants, shrubs, trees, irrigation and drainage systems, and appurtenant facilities and expenses associated with Landscape Maintenance

1	District No. 1 that will be maintained by the City of Rialto through annual assessments.
2	Section 3: The improvements to be maintained by the City of Rialto for Fiscal Year
3	2021/2022 are substantially the same as the improvements provided and maintained in the
4	previous Fiscal Year and the Engineer's Report for Landscape Maintenance District No. 1
5	prepared in connection therewith shall describe the improvements as required by the Act.
6	Section 4: The Engineer's Report for Landscape Maintenance District No. 1 shall
7	reflect provisions and related assessments in accordance with the requirements of Articles
8	XIIIC and XIIID of the California Constitution as enacted by the passage of Proposition 218,
9	also referred to as "The Right to Vote on Taxes Act," as approved by the voters of the State of
10	California on November 5, 1996.
11	Section 5: The Engineer's Report for Landscape Maintenance District No. 1 shall be
12	titled: "City of Rialto, Landscape Maintenance District No. 1, 2021/2022 Engineer's Annual
13	Levy Report."
14	Section 6: The City Clerk shall certify to the adoption of this Resolution.
15	WHEREFORE, this Resolution is passed, approved and adopted this 13th day of July
16	2021.
