## A RESOLUTION OF THE RIALTO UTILITY AUTHORITY BOARD OF THE CITY OF RIALTO, CALIFORNIA, ADOPTING THE FISCAL YEAR 2021/2022 BUDGET

WHEREAS, the proposed budget for fiscal year 2021/2022 of the Rialto Utility Authority (RUA) has been submitted to this Authority Board, and said budget has been considered and, is in form and substance satisfactory to this Authority Board; and

WHEREAS, the Authority may not exceed its appropriations by character of expense, withcharacter of expense being defined as personnel services, services and supplies, capital outlay, debtservice and transfers, without the consent of the Authority Board; and

WHEREAS, the Executive Director may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by the Authority Board; and

WHEREAS, the Executive Director is authorized to make changes to the Adopted Budget only to accommodate actual fund balance as determined at year end and any technical balancing adjustments to appropriations, revenue, and available reserves; and

WHEREAS, the Authority may not hire in excess of the approved number of positions in job classification as indicated by the budget detail without the consent of the Authority Board; and

WHEREAS, it is the intent to ensure that maximum efficiency and savings are realized withinthe Authority, all personnel additions including temporary staffing, shall require approval by theExecutive Director; and

 WHEREAS, the inter-fund borrowings arising from deficit spending in any fund shall require

 Authority Board action to provide for appropriate repayment terms and conditions; and

NOW, THEREFORE, THE RIALTO UTILITY AUTHORITY BOARD OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

7 <u>Section 1:</u> That the budget for the Rialto Utility Authority for the fiscal year 2021/2022 is
8 hereby approved and adopted in the form on file with the City Clerk.

1	Section 2: That specific appropriations for each fund and each operating department are
2	hereby made as set forth in the budget for fiscal year 2021/2022, which are incorporated herein by this
3	reference.
