ELECTING UNDER PUBLIC CONTRA** 22030 4 **SECTION** TO BECOME SUBJECT ТО **PUBLIC** COST ACCOUNTI IFORM CONSTRUCTION 5 ROCEDURES SET FORTH IN THE ACT AND THE TO MMISSION'S POLICIES AND PROCEDURES MANUAL AND 6 COST ACCOUNT REVIEW PROCEDURES AS THEY MAY EACH **BE AMENDED FROM TIME TO TIME** 7 8 WHEREAS, local agencies must competitively bid all public projects (as defined by Section 9 20162 of the California Public Contract Code) in excess of \$5,000 in accordance with the requirements 10 set forth in the Public Contract Code, commencing with Section 20160; and 11 WHEREAS, in 1983, the California Legislature adopted Assembly Bill 1666 which added 12 Chapter 2, commencing with Section 22000, to Part 3 of Division 2 of the California Public Contract 13 Code, which provides for a uniform cost accounting standard for construction work performed or 14 contracted by local agencies and further provides for an alternative method for bidding public projects; 15 and 16 WHEREAS, California Public Contract Code Section 22030 provides that any city that wishes 17 to avail itself of the alternative procedures for bidding and contracting for public projects must elect, by 18 resolution, to become subject to the uniform construction cost accounting procedures set forth in the 19 Public Contract Code and must notify the State Controller of its election; and 20 WHEREAS, the City desires to become subject to the uniform construction cost accounting 21 procedures set forth in the Public Contract Code, commencing with Section 22000; and 22 WHEREAS, California Public Contract Code Section 22034 requires each public agency that 23 elects to become subject to the uniform construction cost accounting procedures to enact an informal 24 bidding ordinance that complies with the requirements set forth in said Section 22034; and 25 WHEREAS, concurrently herewith, the City Council has introduced an Ordinance which enacts 26 procedures governing public works contracts and establishes, among other things, informal bidding 27 procedures in accordance with the requirements of Section 22034 of the Public Contract Code, and 28 generally updates the City's purchasing regulations.

8	California Controller advising of the City of Rialto's action pursuant to Section 1 of this Resolution.
