RESOLUTION NO. 2021-43

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF RIALTO, CALIFORNIA FINDING THAT THE LOCATION, PURPOSE, AND EXTENT OF THE VACATION OF ORCHARD STREET, **MARCELLO** AVENUE, AND PORTIONS OF **JOYCE AVENUE** GENERALLY LOCATED ON THE WEST SIDE OF ACACIA AVENUE AND NORTH OF EAST JAMES AVENUE IS IN CONFORMANCE WITH THE GENERAL PLAN.

WHEREAS, the right-of-way for Orchard Street, Marcella Avenue, and Joyce Avenue, all located within Tract Map No. 17708 was dedicated to the City on December 29, 2017, as Instrument No. 2017-0554325 in Book 348 of Maps, Pages 97 - 99; and

WHEREAS, the Planning Commission conditionally approved Tentative Tract Map No. 17708 on May 30, 2007 and said conditions stated "the necessary right of way shall be dedicated for Joyce Avenue, Orchard Street and Marcella Avenue for private streets and other facilities..." The conditions of approval also required the community to be gated; and

WHEREAS, the City Council approved Tract Map No. 17708 on November 22, 2017 and the County Recorder's Office recorded the map on December 29, 2017. The final map included an offer by the owner to dedicate to the City of Rialto, the public in general and public utility companies and acceptance by the City Council on behalf of the same "an easement for streets and public utilities, sewer, emergency access, in, under, over, through and across Orchard Street, Marcella Avenue and Joyce Avenue, subject to improvement as shown on this final map"; and

WHEREAS, the language in the final map for the offer of dedication and acceptance of "an easement for streets" constitutes street dedication for right of way to the public and not a reservation of a private street as required by the approved conditions for the tentative tract map; and

WHEREAS, the best solution to resolve the incorrect offer of dedication and acceptance of the same is to vacate the right of way in accordance with Streets and Highways Code Section 8300 et seq and included ("Street Vacation") for the City of Rialto ("City") to vacate Orchard Street, Marcella Avenue, and Joyce Avenue, all located within Tract Map No. 17708, as described

herein and depicted in Exhibit A to this Resolution ("Excess Street-Right-Of-Way"); and have the subdivider reserve for itself, assigns and heirs an easement for private access over the streets

WHEREAS, Streets and Highways Code Sections 8300 *et seq.* allow for vacation of excess street right-of-way and access rights; and

WHEREAS, California Government Code Section 65402(a) states, "If a general plan or part thereof has been adopted, no real property shall be acquired by dedication or otherwise for street, square, park or other public purposes, and no real property shall be disposed of, no street shall be vacated or abandoned, and no public building or structure shall be constructed or authorized, if the adopted general plan or part thereof applies thereto, until the location, purpose and extent of such acquisition or disposition, such street vacation or abandonment, or such public building or structure have been submitted to and reported upon by the planning agency as to conformity with said adopted general plan or part thereof. The planning agency shall render its report as to conformity with said adopted general plan or part thereof within forty (40) days after the matter was submitted to it, or such longer period of time as may be designated by the legislative body;"; and

WHEREAS, the General Plan of the City of Rialto Circulation Element does not identify Orchard Street, Marcella Avenue, and Joyce Avenue, all located within Tract Map No. 17708; and

WHEREAS, because the excess street right-of-way of Orchard Street, Marcella Avenue, and Joyce Avenue, all located within Tract Map No. 17708 is not necessary to be reserved, improved, or maintained as a public roadway under the General Plan, it may be vacated by the City.

WHEREAS, all legal prerequisites to the adoption of this Resolution have occurred.

NOW, THEREFORE, BE IT RESOLVED by the Planning Commission of the City of Rialto as follows:

<u>SECTION 1.</u> The Planning Commission hereby specifically finds that all the facts set forth in the recitals above of this Resolution are true and correct and incorporated herein.

SECTION 2. The Planning Commission hereby finds that location, purpose, and extent of the vacation of Orchard Street, Marcella Avenue, and Joyce Avenue, all located within Tract

Map No. 17708, as depicted on Exhibit A to this Resolution, is in conformance with the City's General Plan.

<u>SECTION 3.</u> The Chairman of the Planning Commission shall sign the passage and adoption of this resolution and thereupon the same shall take effect and be in force.
