3 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**  
4 **RIALTO, APPROVING THE APPLICATION FOR OUTDOOR**  
5 **EQUITY GRANTS PROGRAM GRANT FUNDS.**

6 **WHEREAS**, the State Department of Parks and Recreation has been delegated the  
7 responsibility by the Legislature of the State of California for the administration of the  
8 Outdoor Equity Grants Program, setting up necessary procedures governing the application;  
9 and

10 **WHEREAS**, said procedures established by the State Department of Parks and  
11 Recreation require the Applicant to certify by resolution the approval of the application before  
12 submission of said application to the State; and

13 **WHEREAS**, successful Applicants will enter into a contract with the State of California  
14 to complete the Grant Scope program.

15 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES**  
16 **HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

17 **Section 1:** The City Council of the City of Rialto hereby approves the filing of an  
18 application for the Expansion of Mobile Recreation Programs and commits to the following:

- 19 1. Certifies that said Applicant has or will have available, prior to commencement of any  
20 work on the program(s) included in this application, the sufficient funds to complete the  
21 program(s); and
- 22 2. Certifies that if the grant is awarded, the Applicant has or will have sufficient funds to  
23 operate the program(s) as described in the Grant Selection Criterion response, and
- 24 3. Certifies that the Applicant has reviewed, understands, and agrees to the General  
25 Provisions contained in the contract shown in the Grant Administration Guide; and
- 26 4. Delegates the authority to the City Manager to conduct all negotiations, sign and  
27 submit all documents, including, but not limited to applications, agreements, amendments,  
28 and payment requests, which may be necessary for the completion of the Grant Scope; and

1 5. Agrees to comply with all applicable federal, state and local laws, ordinances, rules,  
2 regulations and guidelines.

3 6. Will consider promoting inclusion per Public Resources Code §80001(b)(8 A-G).
