A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, AMENDING RESOLUTION NO. 7766 TO ADD THE BUILDING OFFICIAL AND ECONOMIC DEVELOPMENT MANAGER TO THE LIST OF POSITIONS EXEMPT FROM THE COMPETITIVE SERVICE.

WHEREAS, Ordinance No. 1660 modified section 2.50.060 of Chapter 2.50 of the Rialto Municipal Code to grant City Council the authority to identify positions that are exempt from the competitive service by resolution; and

WHEREAS, on August 10, 2021 the City Council adopted Resolution No. 7766 to list the offices, positions and employer in the service of the City that are not subject to Chapter 2.50 of the Rialto Municipal Code; and

WHEREAS, the City Council now elects to amend the list of exempt positions by adding the Building Official and Economic Development Manager positions; and

WHEREAS, as detailed in Ordinance No. 1660, City employees not included in the competitive service shall serve at the will and pleasure of their appointing authority and may be terminated from employment at any time without cause and without right of appeal or hearing, except where such right is expressly provided by law.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

<u>Section 1:</u> Section 1(b) of Resolution No. 7766 is hereby amended to add the following "Management Unrepresented" positions as exempt from the competitive service pursuant to Rialto Municipal Code section 2.50.060, as modified by Ordinance 1660:

(xiii) Building Official

(xiv) Economic Development Manager
