**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
RIALTO, CALIFORNIA, AMENDING THE 2021-2022 FISCAL  
YEAR BUDGET**

**WHEREAS**, the budget for fiscal year 2021-2022 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

**WHEREAS**, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

**WHEREAS**, the City Manager may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES  
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

**Section 1:** Authorize an increase in estimated revenues in the Office of Traffic Safety Grant Fund, Account No. 221-400-6986-7551- in the amount of \$246,000 for the Office of Traffic Safety – Selective Traffic Enforcement Program (STEP) Grant.

**Section 2:** Approve an appropriation in the Office of Traffic Safety Grant Fund in the following expenditure accounts:

Account No. 221-500-6986-1020 in the amount of \$219,229;

Account No. 221-500-6986-1050 in the amount of \$3,179;

Account No. 221-500-6986-2021 in the amount of \$21,090;

Account No. 221-500-6986-2022 in the amount of \$2,502.
