## 1. PROBLEM STATEMENT

The Rialto Police Department's Traffic division is currently staffed with (1) Corporal, (3) motors and (1) nighttime DUI Enforcement/Accident Investigation (DUI/AI) officer. The four Traffic enforcement officers cover our City (28 sq miles) from 0630 to 0030 hrs Monday thru Friday. These (4) officers are responsible for traffic enforcement, DUIs, and collision investigations. In 2021, our department will be in the position to increase the Traffic division's staffing to (1) Sergeant, (1) Corporal, (6) Motorcycle Officers, (4) DUI/AI investigators and (2) Commercial Enforcement Officers.

The City of Rialto is located in the western portion of the San Bernardino County approximately 19 miles east of the east Los Angeles County line. Rialto's population is over 105,000 residents with an area of about 28 square miles. The City of Rialto sits in the middle of the I-210 to its north, the I-10 to the south, the I-215 to the east and the I-15 to the west. Traversing in and out of Rialto and the surrounding areas, there are thousands of roadway miles (almost 1 million miles driven per year on our roadways) and during most of the day, extremely congested. In the last couple years, Rialto has experienced booms in the construction of homes, large retail complexes, and super warehouses such as Under Armour, Amazon, Target, Niagara Water, Apple, and others. This growth has not only increased the density of the commercial areas, but it brings with it thousands of more trucks, cars, and motorcycles on our roadways causing more congestion, traffic violations, and crashes.

In 2020, the Rialto Police Department issued 8,208 moving, equipment, misdemeanor, and administrative citations. The citations require the subsequent manual entry of citation data into the department's Records Management System (RMS) after which they are hand delivered each day to the Traffic Court in Fontana and the Superior Court in Rancho Cucamonga. The data entry and citation delivery portions of this workflow is a huge drain on our Records personnel.

## 2. PERFORMANCE MEASURES

### A. Goals:

1. Reduce the number of persons killed in traffic crashes.
2. Reduce the number of persons injured in traffic crashes.

### B. Objectives:

1. Purchase and implement a new complete electronic citation solution that includes the capability of exporting data to both a departmental records management system (RMS) as well as the local court records system if and when the local court can receive electronic citation data.

## 3. METHOD OF PROCEDURE

### A. Phase 1 – Program Preparation (1<sup>st</sup> Quarter of Grant Year)

- Determine specific system requirements.
- Determine specific equipment requirements.
- Request vendor price quotation per host agency requirements.
- Procure an electronic citation system with the following functionalities:
  - System licensing with installation and training.
  - Ability to import and export to agency RMS files.
  - Ability to perform complete analysis of citation reports.
  - Secure database accessible by appropriate agency personnel.
  - Ability to export complete citation reports to the local county court.

### B. Phase 2 – Program Operations (Throughout Grant Year)

- Select vendor for system development, implementation, and installation.
- Monitor and oversee progress of system/software development.

### C. Phase 3 – Data Collection & Reporting (Throughout Grant Year)

- Prepare and submit invoice claims (due January 30, April 30, July 30, and October 30).

- Successful project completion and confirmation of successful transmission of citations to the local county courts is required before submission of invoice claims seeking reimbursement from OTS.
- Prepare and submit quarterly performance reports (due January 30, April 30, July 30, and October 30).
  - Collect and report quarterly appropriate data that supports the progress of goals and objectives.
  - Provide a summary of quarterly accomplishments and explanations for objectives not completed.
  - Collect, analyze, and report statistical data relating to the grant goals and objectives.

#### **4. METHOD OF EVALUATION**

Using the data compiled during the grant, the Grant Director will complete the "Final Evaluation" section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant's accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.

The prospective lower tier participant further agrees by submitting this proposal that it will include the clause titled "Instructions for Lower Tier Participant Certification" including the "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion – Lower Tier Covered Transaction," without modification, in all lower tier covered transactions and in all solicitations for lower tier covered transactions and will require lower tier participants to comply with 2 CFR parts 180 and 1200.

7. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that it is not proposed for debarment under 48 CFR part 9, subpart 9.4, debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. A participant is responsible for ensuring that its principals are not suspended, debarred, or otherwise ineligible to participate in covered transactions. To verify the eligibility of its principals, as well as the eligibility of any prospective lower tier participants, each participant may, but is not required to, check the System for Award Management Exclusions website (<https://www.sam.gov/>).

8. Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render in good faith the certification required by this clause. The knowledge and information of a participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.

9. Except for transactions authorized under paragraph 5 of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is proposed for debarment under 48 CFR part 9, subpart 9.4, suspended, debarred, ineligible, or voluntarily excluded from participation in this transaction, in addition to other remedies available to the Federal government, the department or agency with which this transaction originated may pursue available remedies, including suspension or debarment.

**Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion -- Lower Tier Covered Transactions:**

1. The prospective lower tier participant certifies, by submission of this proposal, that neither it nor its principals is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participating in covered transactions by any Federal department or agency.

2. Where the prospective lower tier participant is unable to certify to any of the statements in this certification, such prospective participant shall attach an explanation to this proposal.

**BUY AMERICA ACT**

**(applies to subrecipients as well as States)**

The State and each subrecipient will comply with the Buy America requirement (23 U.S.C. 313) when purchasing items using Federal funds. Buy America requires a State, or subrecipient, to purchase with Federal funds only steel, iron and manufactured products produced in the United States, unless the Secretary of Transportation determines that such domestically produced items would be inconsistent with the public interest, that such materials are not reasonably available and of a satisfactory quality, or that inclusion of domestic materials will increase the cost of the overall project contract by more than 25 percent.
