Chair Frank Gonzalez asked if there were any oral communications from the public not on the agenda. Daniel Casey stated there were none.

PLANNING COMMISSION MEETING MINUTES

Chair Gonzalez announced that the next item on the agenda is Planning Commission Meeting Minutes.

Motion by Commissioner Dale Estvander, second Commissioner John Peukert to move to approve the October 13, 2021, Planning Commission Special Meeting Minutes. All in favor, *motion carried* 5-0-0.

PUBLIC HEARINGS

Chair Gonzalez stated the next item on the agenda is Precise Plan of Design No. 2020-0011.

Senior Planner Daniel Casey presented a request to allow the development of a new concrete block manufacturing plan building, a 10,018 square foot administration building, a 21,360 square foot mechanic shop/storage, a 21,534 square foot metal canopy structure, and associated paving, landscaping, lighting, fencing, and drainage improvements on 32.48 gross acres of land located at the terminus of Fortuna Way and Industrial Drive. A Mitigated Negative Declaration was prepared for consideration in conjunction with the project.

A Traffic Impact Analysis was prepared by NVS and determined the project will generate 758 new daily vehicle trips. Twelve (12) intersections were analyzed and found three intersections will have cumulative impacts—Riverside Avenue and Slover Avenue, Riverside Avenue and Santa Ana Avenue, and Riverside Avenue and I-10 Eastbound ramps. The analysis included recommendations for improvements—widening of Riverside Avenue to six lanes, relocation of traffic signal poles, and acquisition of right-of-way along Riverside Avenue.

On October 6, 2021, the Transportation Commission approved the Traffic Impact Study and determined \$724,398 in Fair Share fees.

Chair Gonzalez opened the Public Hearing.

Edward, President of Angelus Block, Applicant

Angelus Block is in its 75th anniversary and currently operate at two sites adjacent to the proposed site. The proposed project will allow the business to expand, centralize and modernize its operations.

The Commission inquired if there will be retail sales to which the applicant confirmed they do have point of sales on-site.

The Commission asked how Rialto residents will they employ, and the applicant advised roughly 25% of their employees will be Rialto residents.

Motion by Commissioner Dale Estvander to close the Public Hearing, second by Commissioner Artist Gilbert. All in favor, *motion carried* 5-0-0.

Motion by Commissioner Dale Estvander, second by Commissioner Artist Gilbert to approve Precise Plan of Design No. 2020-0011 and Environmental Assessment Review No. 2020-0008. All in favor, *motion carried* 5-0-0.
