Director Alvarado gave updates on department programming:

Recreation Programmer, Che Wilson Received an award from RUSD "Key to the District Award" Special Events assisted with Rotary Club's 27th Run Whatcha Brung Car show and Cruise.

After School Program Teen Center participants assembled and delivered Covid-19 safety kits to the local Senior Communities and received a visit from representatives of Valley College for future education options. Mobile Recreation resumed at Joe Sampson Park on Tuesday's and Thursday's.

Fitness and Aquatic Center welcomed a new Recreation Programmer, C. Wilson who has developed a successful youth sports program at the Community Center.
